Hello to everyone.

Our website is still not up to par. My apologies for it not being updated. I had hoped by now to have the applications available to fill out right on the site but that has not happened. Getting it back in action has now become a top priority. The forum is also down as the site that was hosting it has apparently disappeared. We do have a facebook page that is slowly growing. There is a movement beginning to bring the entire community together. On Presidents day I was invited to attend a meeting in Chicago. This was attended by a dozen representatives form the metal detecting community. It was on short notice so many were unable to make it. There were manufacturers, distributors, an archaeologists and even a lobbyist. The meeting was out together by Minelab to hear from Dr. Norman Palmer. .He is one of the architects of the English Portable Antiquities Scheme and was in Chicago for an event. He took time out to meet with us. He presented a very informative slide show on the system. Giving background info along with a general understanding of how the system functions and adapts. At the end of the meeting a brief discussion took place concerning the US situation. "Where do we go from here?" was the question. It was cut short by a winter storm hitting the area so everyone scattered to hit the airport or the road. Mine was the road and it was not pleasant! It was agreed that more meetings need to take place. We must get organized so all concerns are working together. Without it we will keep on this path of a constant fragmented fight to keep the hobby alive.

England took the steps a couple decades ago to avoid that. On the other end of the scale the countries of Bulgaria and Russia have gone the other direction. Russia has virtually outlawed detecting this past year. If you don't think it could happen here all you need to do is look at the gross violations of the law and the constitution that are being perpetrated by the government and the courts everyday. Do you think that a little item like metal detecting would be even a burp to them?

We are working on moving into the 21st century (pun intended). Shortly we be holding our first internet meeting of officers. In addition we are hoping to use this to actually meet with clubs around the country. A representative of the FMDAC can be on a computer or screen or whatever the club sets up and talk live with the club. This is an effort to make better use of technology and also to make better use of the members funds.

In keeping with that issue we will not be holding a traditional convention this year. At best the officers will be getting together to hold a board meeting. We will be discussing the future of the conventions as they have been held. Attendance has dropped off over the years so we will reevaluate the whole affair. We may go to every other year. And or hold it in conjunction with another event. One of the issues with putting on one is that it takes a lot of resources to put it all together. If a member club has a good location or event in their area and would like to host it then let us know. It is much easier when we have someone in the local area to do the legwork. Should we hold it along with an existing event we would have to make changes to coincide with and work with that event. We will let you know as soon as we make a determination.

A situation has just now, as I write this, come to light in Massachusetts. Seems that the Parks department is rewriting its rules. Apparently there was a comment period and some public meetings in the fall. One of the items that has been changed (it is not in effect yet) is that metal detecting is now being banned. We have no further info and the Northern region director, John Howard is checking into it. Once we research it we will send out that info.

Now on a positive note. A fellow detectorist by the name of Heath Jones is running for an Alabama state house seat. He talked on American Digger Relic Roundup a few weeks ago. Obviously you cannot vote for him unless you are in the Alabama 39th district but you can wish him well. He does have a facebook page you can check out. He has no primary challenger so will be going up against the incumbent in November.
