## **Spring is finally here! Have you got your Forest Green & Gold Cards?**

Hello Friends!

It's time to get out of Dodge and go prospecting! With the price of gold hovering at almost \$2,000 an ounce, it's a bonus incentive to get out into the great outdoors and explore our wonderful public lands. Whether you are exploring new digs or continuing to expand your success on ground that has shown some nice color in the past, get out there and try your luck! PLP has your back while you camp on public land and engage in activities as granted by the U.S. mining law. If for example, the Forest Service tells you that you cannot camp on your mining claim past the camping limit, or use a road on that National Forest, then produce your "PLP Forest Green Card" with the supporting documents and the Forest Service will thank you and go away.

Provided you are actively prospecting, these same materials work on solving many other problems with the Forest Service and found on the "PLP Forest Green Card" given to our members.

PLP has also been issuing "Gold Cards" since last May of 2021. These guide cards enable persons to legally suction dredge in California if they are engaging in legitimate reclamation on their own mining claims (or with permission of the claim owner of record). Those individuals following PLP's "Gold Card" can keep the gold

they find to offset the cost of removing lead, mercury and other trash within the waterway legally, and in most cases without any state permit.

Send PLP an email with a picture of your gold, lead, mercury and other trash pulled out of a waterway this summer with a short story, and we may send you 5 books of grand raffle tickets if you are selected to be posted on our reclaiming our waterways portion of our website. (Please let us know if you wish PLP not to publish your name or watershed location.) By doing so, the mining community can conclusively demonstrate that gold suction dredges can be **repurposed** for reclamation activity for the benefit of cleaning our waterways without costing the taxpayers a dime; and at the same time satisfy improvement requirements of annual assessment work under the Mining law.

Our Forest Green and Gold Cards plus PLP's reference research materials are updated every year based upon any changes in law, regulations and case law. If you like the work PLP does please help us help you by joining or renewing your PLP membership. This will guarantee that you have the latest information to stay ahead of the agencies and your opposition. Why cry tyranny and wring your hands in futility on social media when you can get productive and smart, while working and playing at your chosen pastime.

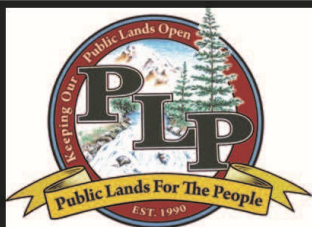
